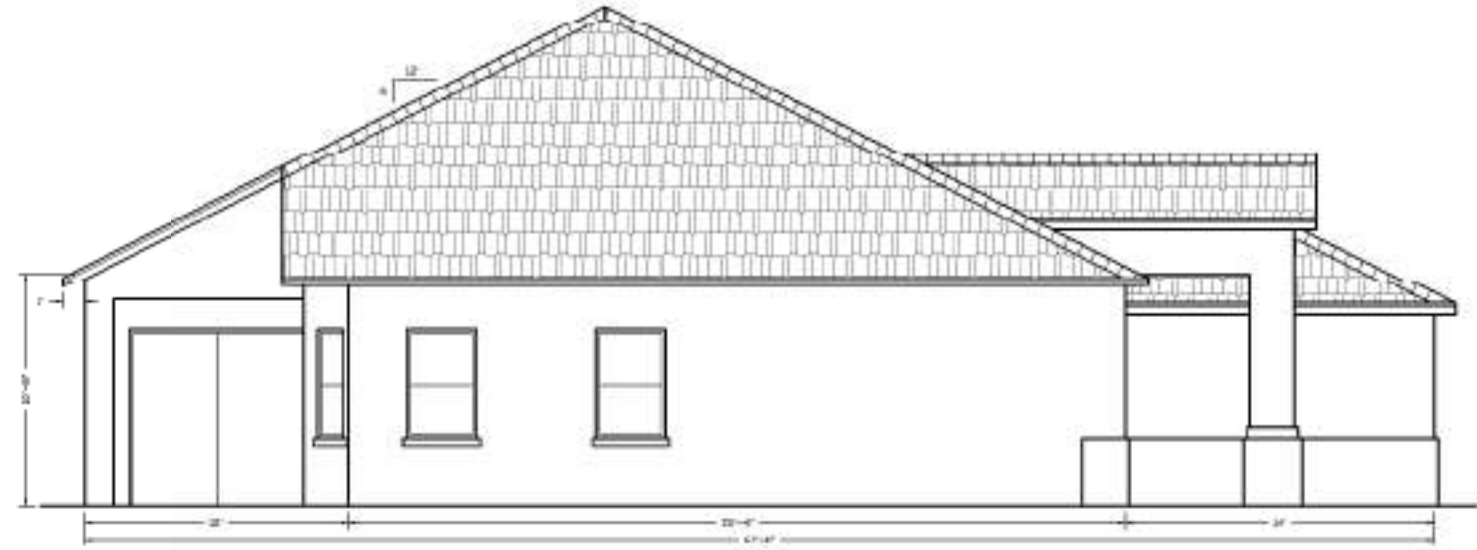
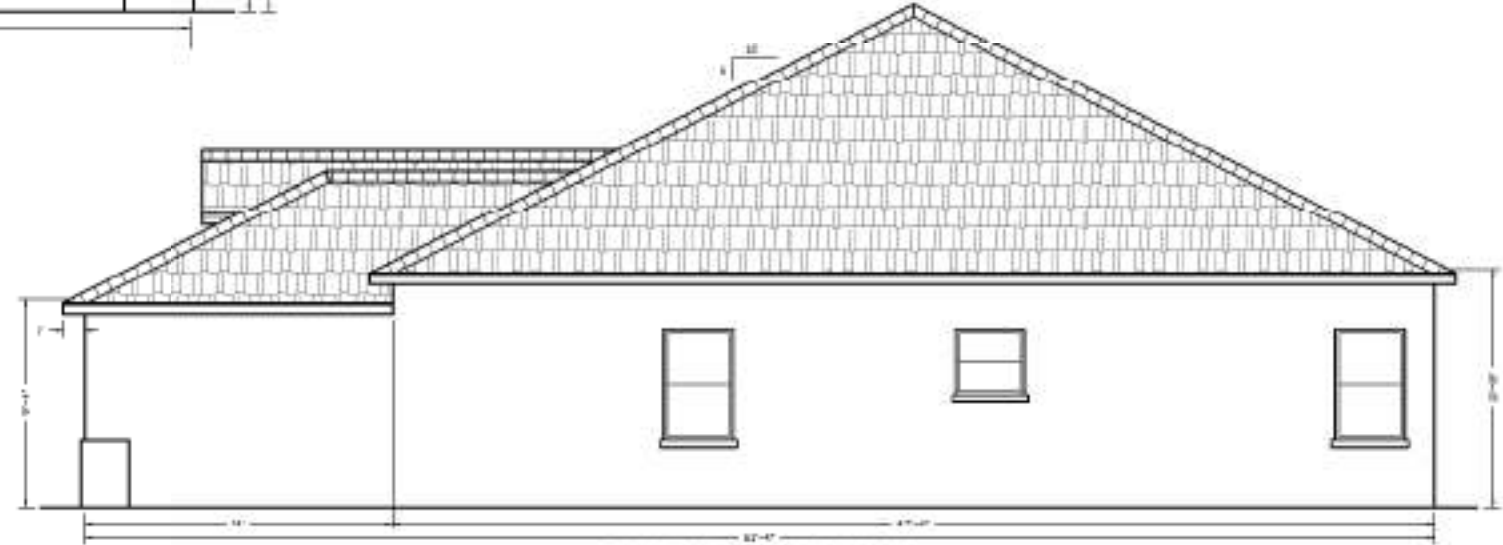




EXISTING FRONT ELEVATION

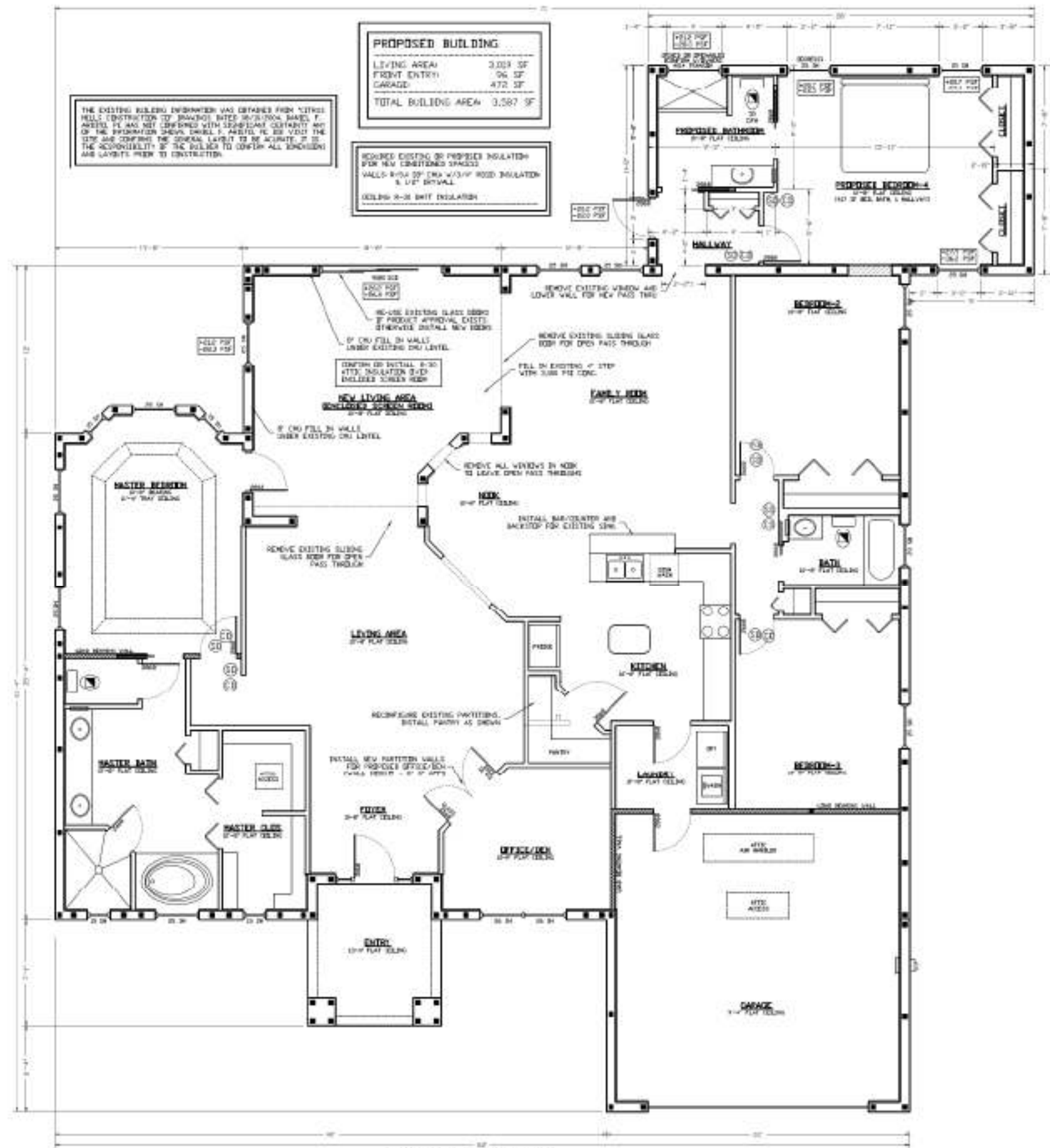

TAPCON SCREW ANCHORS AND BULK BUCK STRIP ANCHORS

1. BULK STRIPS ARE TO BE CONTIGUOUS & PROJECTIONS TO THE TOP AND SIDES OF SPACING BEING AT LEAST 1" PRESSURE TREATED LUMBER.
2. WHEN THE BULK THICKNESS IS 1/2" OR GREATER, THE BULK SHALL BE SECURED & FASTENED TO THE CONCRETE BY ANCHORS AS LISTED BELOW AND WINDOWS OR DOORS SHALL BE ATTACHED TO THE BULK BUCK FOR THE MANUFACTURER'S SPECIFICATIONS.
3. INSTALL TAPCON SCREWS PER MANUFACTURER'S GUIDELINES. TIGHTEN SCREWS TO 50 LB - DO NOT OVER TIGHTEN. REMOVE PROTECTION DURING OR OF CONCRETE 1-2".
4. ANCHOR SPACING IS FOR WINDOWS OR DOORS. BULK STRIPS AT THE TOP AND SIDES OF SPACING THE TAIL OF BUCKS AND WINDOWS ARE TO BE ATTACHED PER MANUFACTURER'S INSTALLATION INSTRUCTIONS. EQUALLY SPACE ALL ANCHORS.
5. MANUFACTURER'S SPECIFICATIONS SUPERSEDE THESE TABLES AS INDICATED.

6. PROVIDE MINIMUM 10-MINUTE SCREWS INTO EACH BULK STRIP.

GARAGE DOOR BUCK FASTENING (IF BUCKS ARE USED)

1. WOOD BUCKS SHALL BE 2x6 FT MIN.
2. AFTER THE WOOD BUCK IS TO THE CONCRETE, BRACKET WITH ANCHORS AT 4" INTERVALS PER MANUFACTURER'S INSTALLATION INSTRUCTIONS. EQUALLY SPACE ALL ANCHORS.
3. EXTREMITIES BUCK FASTENINGS SHALL NOT EXCEED 24" OC AND SHALL BE 2'-0" TO 4'-0" INTERVALS TYPICAL.

THE BUILDER IS RESPONSIBLE FOR OBTAINING NECESSARY APPROVALS FOR EXISTING WINDOWS AND DOORS BASED ON MANUFACTURER'S SPECIFICATIONS. BULK BUCKS ARE NOT TO BE USED FOR ALUMINUM OR STEEL BUCKS. VERTICAL WALL STEEL MAY BE RELOCATED OR BUILT OVERHANGS WITHIN ONE WALL & MAXIMUM OF 4" FROM EXISTING AS INDICATED IN PLANS TO SPAN REQUIRED ROOM DIMENSIONS INDICATED ONLY.
